New Energy Star® Certified Appliances

Complete application form, attach receipt and yellow energy guide label with Energy Star logo.

- \$40 dishwasher
- \$60 per unit for refrigerator or freezer (7.75 cubic foot or larger), top load clothes washer, clothes dryer.
- \$80 front load clothes washer.
- \$120 hybrid clothes dryer (vent-less).



Refrigerator/Freezer Recycling

Year long event. *Limit 2 units per year.*

- \$60 Take your unit to be recycled pay the recycle fee, then submit your receipt and application to EEA to receive your credit.

Electric Water Heaters*

Complete application form, attach receipt and photo of yellow energy guide label.

- \$60 basic unit - 30 - 55 gallon resistance water heaters
- \$100 lifetime tank warranty 30 - 55 gallons e.g. Rheem Marathons®
- \$350 heat pump water heater 30 gallon minimum (air to water and may have a back-up resistance element). *Must be Energy Star*

Residential LED Lamps

Complete application form, attach receipt and a empty box of each style of bulb.

- LED lamps and LED fixtures **500 lumens or greater.**
- 50% of lamp or fixture, cost capped at \$8.
- Maximum of 50 lamps per membership per year.

Outdoor Electric or Battery Powered Equipment

Complete application form, attach receipt and a photo of box. Max Total Rebate \$300 per member per year.

- Lawn Mower or Snow Blower - Corded or Min. Battery 36 Volts 25% of price up to \$150
- EBike - 25% of price up to \$150 - Retrofit Kits do not qualify for Rebate
- Leaf Blower, Trimmer, Pruner, Chain Saw - Corded or Min. Battery 18 Volts 25% of price up to \$50

- Level 3 w/Network Capability: Charger - up to \$3000 *Must be Large Power Rate*

Energy Star® Rated Split System Air-Conditioners*

- \$200 per unit for split system Energy Star® rated air-conditioners above 16 SEER. *Permanent Installation (Minimum size - 1 ton)*

Electric Heat Pump – Air Source*

(Minimum size - 1 ton capacity)

*** EEA's Rules and Regulations require you to advise EEA when making any material changes or increases in your connected load. Call EEA Engineering at (970) 564-4406 to schedule an assessment before you purchase your new equipment. Rebates may be denied if you refuse to install required service upgrades.**

- \$170 per unit for terminal units (PTACs similar to the typical under-window hotel room units).
- \$300 per ton for central air source "split" or "mini-split" (ductless) units with SEER of 15 to 17. *Not to exceed 50% of equipment cost.*
- \$600 per ton for central air source "split" or "mini-split" (ductless) with SEER greater than 17. *Not to exceed 50% of equipment cost.*
- \$200 per unit additional incentive for central air source with integrated Electric Thermal Storage backup.
