Credit must be requested within 120 days of installation.

Retrofits, New Construction, and Exterior Lighting

Contact our Energy Management Advisor to find out about incentives paid for other kinds of lamps and fixtures.

Incentives are paid based on the type of lamp or fixture installed. For example:

- LED 3ft or 4ft Linear Replacement Lamp \$3/Lamp Incentive
- LED Exit Sign \$7/Sign Incentive
- LED Low Bay (8k to 10k lumens) \$45/Lamp or Fixture
- Incentives are capped at 50% of invoiced fixture or lamp material cost. Each project is capped at \$20,000.

Pole Mounted Lighting

- Incentives are paid based on the minimum fixture lumens
- Incentives are capped at 25% of invoiced cost for each head or retrofit kit. Each project is capped at \$20,000.

Refrigerated/Freezer Case LED Lighting

Contact our Energy Management Advisor for details.

- \$60 per door for reach-in cases.
- \$10 per linear foot for top lighting of multi-deck open cases
- Incentives are capped at the lesser of 50% of the fixture material cost or \$3,000 (50 doors or equivalent) per member-owner account location.

Refrigerated Case/Walk-in Cooler Fan Motor Retrofit

- \$50 per installed retrofit fan motor.

Electric Water Heaters

Complete application form, attach receipt and photo of yellow energy guide label. Contact our Energy Management Advisor concerning heat pump questions.

- \$60 basic unit - 30 - 55 gallons resistance water heaters
- \$100 lifetime tank warranty 30 - 55 gallon e.g. Rheem Marathons®
- \$200 ground source heat pump powered or desuperheater (waste heat system) \$50 for lifetime tank on desuperheater.
- \$700 heat pump water heater 30 gallon minimum (air to water and may have a back-up resistance element)

Energy Star® Rated Split System Air-Conditioners

(Minimum size - 1 ton capacity)

- \$200 per unit for split system Energy Star® rated air-conditioners of 15 to 16 SEER.
- \$300 per unit for split system Energy Star® rated air-conditioners above 16 SEER.

Electric Heat Pump – Ground Source

(Minimum size - 3/4 ton capacity)

- \$1,000 per ton for new ground source systems using either ground source closed loop or ground water source. \$500 per ton for replacement system.

Electric Heat Pump – Air Source

(Minimum size - 1 ton capacity)

- \$170 per unit for terminal units (PTACs similar to the typical under-window hotel room units).
- \$600 per ton for central air source “split” or “mini-split” (ductless) units with SEER of 15 to 17.
- \$900 per ton for central air source “split” or “mini-split” (ductless) with SEER greater than 17.
- \$200 per unit additional incentive for central air source with integrated Electric Thermal Storage backup.
